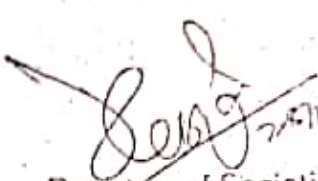

MEMORANDUM OF ASSOCIATION

77

1. The name of the Society is the "Navyug School Education Society" (hereinafter referred to as the Society).

2. Status of the Society is an Educational Society.

3. The registered Office of the Society will be situated in New Delhi or at such other place or places as the Society determine from time to time. At present it has the

Navyug School,
Pahargana, No. 1,
New Delhi.

4. The objects for which the society is established are:-

(a) to establish, endow, maintain, control and manage schools, hereinafter called "Navyug School" and to do all acts and things necessary for or conducive to the promotion of such schools which will have the following objectives:-

(i) to provide good quality modern education including a strong component of Ingle education of vocational training of environment, adventure, art, music and physical education to the talented children (predominantly from the lower middle income group) without regard to their familial socio-economic condition.

(ii) to provide facilities, at a suitable stage, for instruction through a common medium, i.e. Hindi and English.

(iii) to offer a common co-curriculum for enrichment of personality, to standardize and to facilitate the

understanding of the common and composite heritage of people.

(b) to do all such things as may be considered necessary, incidental or conducive to the attainment of all or any of the objectives of the Society.

5. The income and property of the Society, howsoever derived, shall be applied towards the promotion of the objects thereof as set forth in this Memorandum of Association subject to such condition or limitation as NDMC may, from time to time impose. No part of the income and property of the society shall be paid or transferred, directly or indirectly by way of dividends, ^{bonus} ~~bonuses~~ or otherwise, howsoever by way of profits, to the persons or at any time have been members of the Society or to any of them or to any persons claiming through them or to any of them provided that nothing herein contained shall prevent the payment in good faith or remuneration to members thereof or other person in return for any services rendered to the Society or of travelling allowance or other similar charges. No members of the Society shall have personal claim on any moveable or immovable properties of the Society or make any profits whatsoever by virtue of his membership.

6. The New Delhi Municipal Committee may, from time to time, appoint one or more person to review the work and progress of the Society and to hold enquiries into the affairs thereof.

7. The New Delhi Municipal Committee may suo moto or on the representation of the review referred to in the preceding paragraph issue such directions to the Society as

It may be considered necessary for furtherance of the objectives of the Society and for ensuring its proper and effective functioning and the Society shall be bound to comply with such directions.

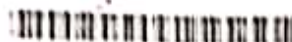
